### Part A: Pupil premium strategy plan

#### **Statement of intent**

Our intention at **Cromwell Junior & Infant School** is that the Pupil Premium grant is used to ensure our disadvantaged pupils have the opportunity to overcome any one of a range of barriers that can impact on individual learning. We believe that with appropriate support all pupils can realise their full potential and broaden their horizons.

Our approach will be responsive to common challenges and individual needs and will complement each other to help pupils excel. To ensure its effectiveness we will ensure practitioners have high expectations of all pupils and they challenge disadvantaged pupils across all areas of the curriculum, alongside their peers. In this way, needs and interventions, will be identified at an early stage, inclusive of those attaining age-related expectations but having the potential to progress further.

Our ultimate objectives are to:

- Remove barriers to learning created by poverty, family circumstance and background
- Narrow the attainment gaps between disadvantaged pupils and their nondisadvantaged counterparts, both within school and nationally
- Develop confidence in pupils' ability to communicate effectively in a wide range of contexts
- Ensure all pupils are able to read fluently, and with good understanding, to enable them to access the breadth of the curriculum, but also to affect their proficiency as writers themselves
- Enable pupils to look after their social and emotional well-being and to further develop their resilience
- Secure their access to a wide range of opportunities that will develop pupils' knowledge and understanding of the world and prepare them for citizenship

#### Achieving our objectives:

In order to achieve our objectives and overcome identified barriers to learning we will:

- Provide all teachers with high quality CPD to ensure that pupils access effective quality first teaching
- Provide targeted intervention and support to quickly address identified gaps in learning through the use of small group work and 1:1 tuition
- Target funding to ensure that all pupils have access to trips, workshops and first-hand learning experiences
- Provide opportunities for all pupils to participate in enrichment activities including sport and music
- Provide appropriate nurture to support pupils in their emotional and social development

This is not an exhaustive list and strategies will change and develop based on the needs of individuals.

Key principals:

• We will ensure that effective teaching, learning and assessment meets the needs of all pupils through the rigorous analysis of data. Class teachers will identify and implement

specific intervention and support for individual pupils, which will be reviewed at least termly. Alongside academic support, we will ensure that those pupils with social, emotional and mental health needs will access high quality provision from appropriately trained adults within school and/or via external agencies.

#### Challenges

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

Challenge number	Detail of challenge
1	Assessments (Wellcomm data / SALT), observations and discussions with pupils indicate underdeveloped oral language skills and vocabulary gaps among many disadvantaged pupils. These are evident from Reception through to KS2 and, in general, are more prevalent among our disadvantaged pupils than their peers. <i>Evidence will be gathered through book looks, learning walks, lesson observations and</i> <i>formative assessment.</i>
2	Assessments, observations and discussions with pupils suggest disadvantaged pupils generally have greater difficulties with phonics than their peers. This impacts negatively, on their development as fluent, independent readers. <i>Evidence will be gathered through formative assessments</i> .
3	Our assessments and observations indicate that the education and well-being of many of our disadvantaged pupils have been impacted by partial school closures to a greater extent than for other pupils. These findings are supported by national studies. This has resulted in significant knowledge gaps, leading to pupils making slow progress and/or falling behind age-related expectations, in core subjects, but especially in English and particularly in writing. <i>Evidence will be gathered through book looks, learning walks, lesson observations and formative assessment.</i>
4	Our assessments, observations and discussions with pupils and families have identified social and emotional issues for many pupils, notably due to limited socialisation and a lack of enrichment opportunities during school closure. These challenges particularly affect disadvantaged pupils, including their attainment. <i>Evidence will be gathered through pupil voice discussions (e.g. pupil/parent questionnaires) as well as teacher observations.</i>

Subsequent 'development days' look to ensure pupils	Pupils continue to access high quality synthetic phonics sessions on a daily basis and develop their ability to apply letter knowledge / decoding skills, independently to the reading and understanding of simple texts.	2

Speech & Language Therapist provides CPD for staff enabling them to maintain targeted intervention / incorporate within classroom practice.	Pupils requiring SALT interventions receive regular input and have sufficient opportunity to meet identified targets and further progress their learning. Speech, language and communication skills are crucial to young children's overall development. Being able to speak clearly and process speech sounds, to understand others, to express ideas and interact with others are fundamental building blocks for a child's development. EEF - A focus on developing oral language skills is especially important for the development of a range of reading and writing skills in this age group.	1
Additional teaching assistants in place, enable each year group to implement further interventions to accelerate pupil progress.	Additional adults allow for the provision of small group work / one to one tuition addressing gaps in learning and/or misconceptions through immediate feedback. EEF Toolkit - Additional small group support can be effectively targeted at pupils from disadvantaged backgrounds and should be considered as part of a school's Pupil Premium strategy. The average impact of the deployment of teaching assistants is about an additional four months' progress over the course of a year. Evidence shows that small group tuition is effective and, as a rule of thumb, the smaller the group the better. Some studies suggest that greater feedback from the teacher, more sustained the engagement in smaller groups, or work which is more closely matched to learners' needs explains this impact. Once group size increases above six or seven there is a noticeable reduction in effectiveness.	1&3
Integration assistants are employed to support disadvantaged SEND pupils with complex needs.	Integrations assistants implement a personalised curriculum to meet the social and emotional needs of a pupil, alongside their learning needs. EEF - The strategic deployment of Teaching Assistants (TAs) will also be important in ensuring pupils with SEND are supported, and TAs should be fully prepared for their role, supplementing rather than replacing high-quality provision from the class teacher. Schools must continue to avoid unintended consequences, such as prolonged separation from peers and teachers, and select evidence-based, targeted interventions that are closely monitored.	1,2,3 & 4
Home learning is developed through the purchase of the online learning platforms – Atom Prime (KS2) and Education City (KS1).	Home learning via the online learning platforms is more accessible to pupils and parents alike. Learning can be personalised and incorporate immediate feedback. Additional programmes can be accessed for SEND and EAL pupils (Lexia) as well as specific subjects e.g. multiplication via TTRS making them more appropriate to individual needs. EEF evidence suggests parents play a crucial role in supporting their children's learning and levels of parental engagement are consistently associated with better academic outcomes.	3

## Wider strategies (for example, related to attendance, behaviour, wellbeing)

#### Budgeted cost: £49,000.00

Activity	Evidence that supports this approach	Challenge number(s) addressed
In house (Drawing & Talking Therapy, Social Skills & Nurture Grp) and external agencies (School Nurse, Take a Step -Counselling Therapy Services) work across the school delivering pastoral support in class and therapeutic work with small groups and/or one to one sessions to improve disadvantaged pupils' social, emotional health and mental well- being. Continuation of Magic Breakfast ensures provision of classroom bagels at the beginning of the day so no pupil starts the day hungry and unable to concentrate on their learning.	For pupils to learn and engage successfully with the curriculum it is important that any underlying social, emotional and mental well-being issues are addressed. EEF - Evidence suggests that children from disadvantaged backgrounds have, on average, weaker Social and Emotional Learning (SEL) skills at all ages than their more affluent peers. These skills are likely to influence a range of outcomes for pupils: lower SEL skills are linked with poorer mental health and lower academic attainment. Social and emotional learning approaches have a positive impact, on average, of 4 months' additional progress in academic outcomes over the course of an academic year.	4
All pupils given the opportunity to participate in activities which enhance and broaden the curriculum and their learning experiences through the subsidising of workshops, visits and music sessions. Animals / animal technician enhances learning environment and supports enrichment of non-core subjects.	Research has shown that providing pupils with additional opportunities, increases pupil engagement and attendance. In turn this improves attainment and works to close the disadvantaged gap. EEF states that all children deserve a well-rounded, culturally rich, education. As such, enrichment approaches can directly improve pupils' attainment. The average impact of successful enrichment interventions is an additional four months' progress over the course of a year.	3 & 4
Senior leaders facilitate in-depth learn- ing reviews and set agreed targets be- tween pupils, parents and teachers.	Pupil progress meetings take place with staff and targets are shared with pupils and also discussed in parent consultations. Parents play a crucial role in supporting their children's learning, and levels of parental engagement are consistently associated with better academic outcomes. Evidence from EEF's Teaching and Learning Toolkit suggests that effective parental engagement can lead to learning gains of +3 months over the course of a year.	3

### Part B: Review of the previous academic year

#### **Outcomes for disadvantaged pupils**

Our assessments and observations in the academic year indicated that pupil behaviour, well-being and mental health continued to be significantly impacted by the Covid-19 pandemic. The impact was particularly acute for our disadvantaged pupils. Pupil Premium funding was used to provide well-being support for all of our pupils and therapeutic targeted group or one to one intervention where required.

Given the restrictions experienced during the pandemic, all pupils were given the opportunity to participate in activities which enhanced and broadened the curriculum and their learning experiences. Pupil Premium subsequently funded workshops, the uptake of educational visits and individual music sessions.

Focused use of teaching assistants allowed same day intervention in order to address identified gaps in learning in all year groups.

End of year data has been analysed and aspects of our findings will be addressed within the academic year 2022 – 2023.

Provision was developed across **EYFS** (30 pupils) to provide high quality child led learning with a focus on early language skills. 70% of all pupils reached a Good Level of Development (GLD) with 72.7% of children eligible for FSM achieving this standard. Outperforming their more affluent peers, this level of attainment was reflected in most of the ELG components excepting Literacy which was in line with peers not eligible for FSM (-1). There was however a more noticeable gap (-6.2) within Mathematics.

Within the Yr.1 **Phonic Screening Check** 90% of the pupils (30) met the expected standard with 87.5% of disadvantaged pupils. While they were outperformed by the non-disadvantaged (92.9%), data for both was above national. There was a gap of 5.4 in relation to gender performance, with boys outperforming girls in meeting expected outcomes.

**In Yr.2**, **end of key stage one** performance showed 76.7% of the cohort (3 pupils) achieving the expected standard in reading, 776.7% in writing, 76.7% in mathematics and 66.7% in reading, writing and mathematics combined. Girls significantly outperformed boys and non EAL learners overall, performed better than their counterparts. Non-disadvantaged pupils outperformed disadvantaged pupils in reading and writing (-17.5), but this was reversed for mathematics (and subsequently reading, writing and mathematics). The performance of non-disadvantaged pupils in maths stands at 55.6% - lower than national (73%). In response, this group will be a focus of the next academic year.

An additional booster teacher allowed smaller sets in **Year 6** (30 pupils) in order to accelerate progress and prepare children for secondary school. Revised data shows 100% of the cohort achieved the expected standard in reading, 86.7% in writing (TA), 100% in maths and 86.7% in reading, writing (TA) and mathematics combined. The percentage of pupils achieving a higher standard in reading and maths / greater depth in writing (TA) was similarly higher than national. Within reading, the nondisadvantaged performed better than the disadvantaged though there is a significant difference in terms of the size of the groupings 7:23 respectively. In maths the groupings were on a par with one another while the disadvantaged outperformed the non-disadvantaged in writing. These findings will feed in to the Pupil Premium strategy for the next academic year.

Schools are not required to publish their 2022 KS 2 results as DfE is not publishing this data. This is because statutory assessment returned for the first time since 2019 without adaptations, after disruption from the pandemic.
